Ujjain Sahakari Dugdha Sangh Mydt, Ujjain (USDSMU), an ISO certified cooperative Organization, invites tenders For supply of Liquid Nitrogen & Rifling Approx. 78000 Liter Yearly (LN<sub>2</sub>) from reputed manufacturer/distributor/dealer strictly in adherence to the detailed specifications given in the tender (as under). Ujjain Sahakari Dugdha Sangh Mydt., Ujjain reserves the right to accept or reject any or all tenders, which in their opinion justify such actions, without further explanation to the tenderers.

Capacity of containers : TA55/TA35 (1630 Lit. ) for refilling after every 7 days

**Terms & Conditions:**

**1.0 TENDER SUBMISSION:**

- 1.1 Tenders received by e-mail will not be considered. However, amendments by e-mail to a tender sent will be considered, provided the same are received before the opening of the tender and confirmed by post.
- 1.2 Individuals signing on the tender and other related documents must specify in which capacity of the firm he/ she has signed the documents. (copy to be uploaded—mandatory)
- 1.3 The tenderer (s) should clearly state in their offer the address, telephone, fax, e-mail, PAN and GST. Any change in the address should immediately be communicated to the Chief Executive Officer, Ujjain Sahakari Dugdh Sangh Mydt, Ujjain and correspondence thereafter will be made at the changed address.
- 1.4 Negligence on the part of tenderer in filling the tender form offers him/her no right to withdraw the tender after it has been opened.
- 1.5 The acceptance of the tender and award of the purchase order will be the sole right of the Chief Executive Officer, Ujjain Sah. Dugdha Sangh Mydt. Ujjain who does not bind himself to accept a tender in whole or in part or reject any or all the tenders received without assigning any reasons and no explanation can be demanded of the cause of rejection of the tender by any tenderer.
- 1.6 The Chief Executive Officer, USDSM reserves the right to place order for whole requirement with any tenderer or split the orders among one or more tenderers or not to purchase at all any item even after rate approval.
- 1.7 Each tender should be accompanied with copy of PAN, GST.
- 1.8 The Tenderers should submit the tender rates in the Schedule IV only. The conditional tenders are liable to be rejected.
- 1.9 No person or firm is permitted to submit more than one tender under different names.

- 1.10 The tenderer shall not sublet the contract or assign to any other party or parties, the whole or any portion of the contract without prior written permission of Chief Executive Officer, USDSM during the supply.
- 1.11 Demonstration of equipment, machines or articles available with the firm shall be arranged by the tenderer at his own cost, whenever requested by Ujjain Sah. Dugdha Sangh Mydt.
- 1.12 Manufacturers will be given preference. Copy of license is to be attached with tender for each item filled in, wholesalers dealing with the item will have to attach copy of authorization certificate of the manufacturer. (copy to be uploaded –mandatory).
- 1.13 Tenderer shall fill all the details of the unit in the enclosed form- A in schedule-III. (copy to be uploaded – mandatory).
- 1.14 ARC (Annual Rate Contract) will Remain for 3 Years.
- 1.15 Bid Validity will Remain for 90 Days.

## **2.0 EARNEST MONEY DEPOSIT: (As detailed in Price bid form)**

- 2.1 All the tenderers are required to deposit Rs.1,00,000/- Pay by Online Payment.
- 2.2 Any tender which is not accompanied with Earnest Money deposit are liable to be rejected. Earnest money deposit of unsuccessful tenderers will be returned within 60 days from the date of opening of the tender. The earnest money deposit of the successful tenderers will be released on completion of supply/work as the case may be within the stipulated period without any interest amount.
- 2.3 No interest will be paid on the earnest money for the period during.
- 2.4 Accepted tenderers are required to deposit Rs.1,00,000/- As a Security Deposit. That's amount taken after the tender.
- 2.5 MSME units of the M.P. State will be exempted from depositing EMD in the tender. (Please submit Certificate/Document)

## **3.0 PRICES:**

- 3.1 Rate should be quoted for the material as per the specifications given in the schedule II of the tender document. In case of any doubt as to the meaning of any of the terms & conditions or the specifications, the tendering firm may set forth the particulars there of and submit them to the Ujjain Sah. Dugdha Sangh Mydt, in writing that such doubts may be removed before submitting the tender.
- 3.2 Prices offered by the tenderers should be firm and free from all escalations and shall be valid at least for a period of 3 Years from the date of approval of rates. We would communicate our rate approval within 60 days of opening of technical bids.

- 3.3 TheTenderer should quote their unit rate on F.O.R Dairy Plant Ujjain basis i.e. **Successful firm/agency have to carry the empty container on their own expenses from UDS & return / delivery within 5 days after refilling/refill the containers at the site. The successful firm/agency can also refill the container at the premises of UDS.**
- 3.4 The estimated requirement is approximate 6500 litres per month. (Yearly Aprox 78000 Lit. Required). The quantities mentioned in this tender are tentative and may vary on either side ( $\pm 15\%$ ). Bidder to Supply materials as per actual requirement. Payment shall be made as per actual material supplied at site.
- 3.5 The rates to be quoted As per Boq (incl. GST).
- 3.6 The prices charged for the material supplies under the contract by the supplier firm in no event shall exceed the lowest price at which the supplier firm sells the material of identical tender description to any other persons/ firms during the period and until the execution of all supply orders placed during contract period.
- 3.7 The lowest rate shall not be the only criteria for approve the tender.
- 3.8 Award Criteria: - UDS will award the contract to the successful bidder whose bid has been determined to be substantially responsive and has been determined as the lowest evaluated bid.
- 3.9 Signing of Contract: - Immediately on receipt of the Purchase Order/ARC, the successful bidder shall return the duplicate copy of the Purchase Order/ARC as token of acceptance, duly signed and sealed to UDS.
- 3.10 If needed, Negotiations will be done for prices and as well as terms & conditions; only with the bidder which offers the lowest rate.
- 3.11 Rights Reserved by UDS: - The UDS reserves the right to postpone/cancel the e-bidding at any stage.

#### **4.0 MODE OF DESPATCH**

- 4.1 The material to be supplied by successful firm shall be dispatched to the UDS under prior intimation. Depending upon the type of material, the supplier shall have to carry out proper packing/crating to avoid damage during transit.
- 4.2 Wharfage /Demurrage etc. on account of incorrect or delayed delivery/dispatches of material/documents must the responsibility of supplier and shall be recovered from the bills.

#### **5.0 LIQUIDATED DAMAGES;**

- 5.1 The time period and the date of delivery of the material stipulated in the purchase order shall be deemed to be the essence of the contract. Once firm delivery date(s) are fixed for supply of material they shall be strictly adhered too. In case they are not followed, or in case of delay in execution or nonexecution of the order, the Dugdha Sangh reserves the right either to cancel the order and make alternative purchases from other sources, at the risk and cost & expenses of the defaulting supplier. In case the supplies are not affected as per the schedules, the liquidated damages may be charged on the goods not so delivered as under:-

S.No.	Duration of Delay	Liquidated Damages
01	Up to 15 days	1% cost of the order value
02	Between 16 to 30 days	2% cost of the order value
03	Beyond 30 days	Upto 5% cost of the order value

5.2 If the tenderer fails to make supply as per purchase order without any valid reason, the order would be treated as cancelled and the firm may be blacklisted for future dealings and EMD also would be forfeited by the management.

5.3 If for any reason the successful bidder refuses to accept purchase order / fails to supply as per purchase order / backs out at a later date then the UDS reserve the right to cancel the order and make purchases from other available alternate sources, at the risk and cost & expenses of the defaulting bidder supplier and firm could be blacklisted for all future dealings. Also the EMD/Security deposit would be forfeited by UDS. NO correspondence will be treated/accepted regarding this.

#### **6.0 INSURANCE:**

In case where the purchase order is placed on “free delivery at site” including unloading basis, no insurance premium will be paid by the purchaser (union/federation). In such a case, all required insurance policies (Transit risk insurance policy, storage insurance policy, All risk policy, workmen compensation policy, third party insurance etc.) may be obtained by the supplier/contractor to safeguard their own interests and to protect the material against transit hazards, storage (at Site) for damage/loss.

#### **7.0 INSPECTION:**

7.1 All the materials supplies are subject to inspection at our stores before acceptance. If goods are rejected due to defective or wrong supply, the report of our authorized official in this respect shall be FINAL and no correspondence on the subject would be entertained. The rejected goods should be removed from our premises by the tenderer within 15 days after receipt of our inspection report failing which the same shall be returned to the supplier at his risk and expenses or disposed off in auction and the proceeds, if any, less expenses would be credited to tenderer's account.

7.2 Sample of the articles should be sent/produced before the competent authority if asked for within 3 days or as mutually agreed.

#### **8.0 PAYMENT:**

100% payment shall be released within 30 days against satisfactory completion of services. The payment shall be released on **monthly basis** for the services executed. The payment shall be made through account payee cheque/NEFT/RTGS.

Our normal terms of payment is full payment after receipt, inspection and acceptance of materials in our stores within a period of about 45 days after receipt. Such payment shall be made through accounts payee cheques/RTGS.

#### **9.0 TERMINATION OF CONTRACT:**

If any act of commission or omission of a unit under contract brings Ujjain Sah. Dugdha Sangh Mydt. To dispute, then the Milk Unions shall be competent to debar/blacklist the unit from further business and terminate the tender without notice to the supplier.

#### **10.0 CONSEQUENCES OF BREACH OF AGREEMENT:**

If any firm under the contract commits breach of any of the conditions, it shall be lawful for the Chief Executive Officer, Ujjain Sahakari Dugdha Sangh Mydt. To cancel the contract and to purchase material from any other alternate sources on the risk and cost of the defaulting unit.

#### **11.0 DISPUTE ARBITRATION & FINAL AUTHORITY:**

11.1 It should be clearly understood that in the event of a successful tenderer failing to accept and execute the supply order, then decision of the Chief Executive Officer, Ujjain Sahkari Dugdha Sangh Mydt., in this respect will be final and binding on the successful tenderer.

11.2 For all matters of dispute, the decision of the Honourable Chairman, Ujjain Sah. Dugdha Sangh Mydt. Under Arbitration and Conciliation Act. 1996 shall be final and binding on all the concerned.

11.3 For all disputes, the venue for legal course shall be at Ujjain.

#### **DECLARATION**

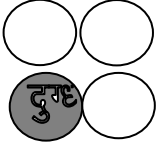

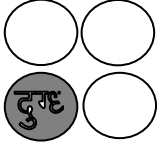

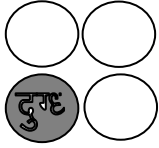
